Cyber protection

Wi-Fi network scan and alerts

Mobile safe browsing and phishing protection

VPN

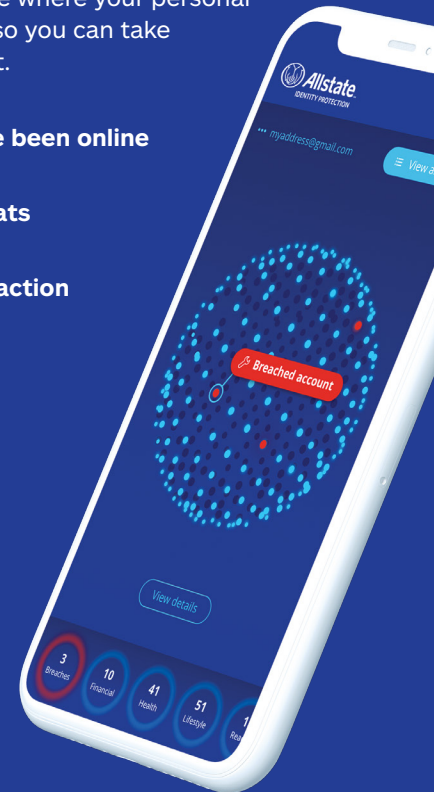

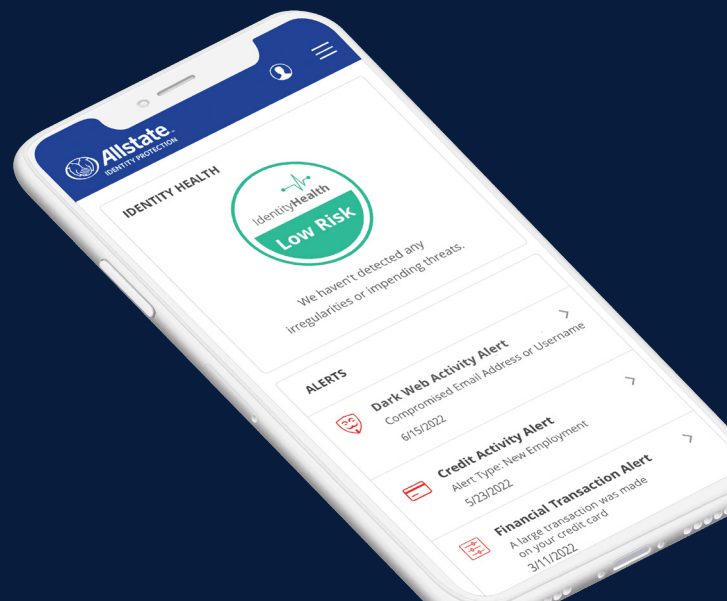
